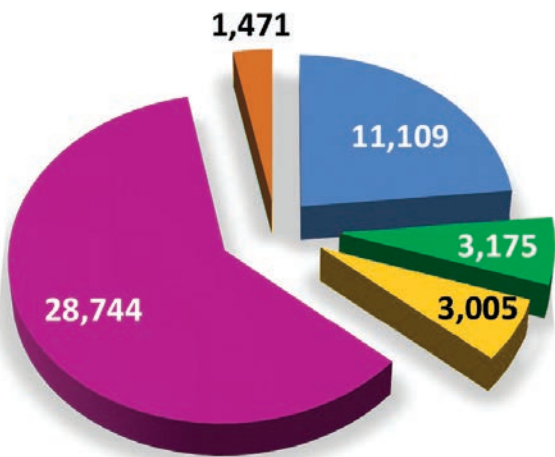

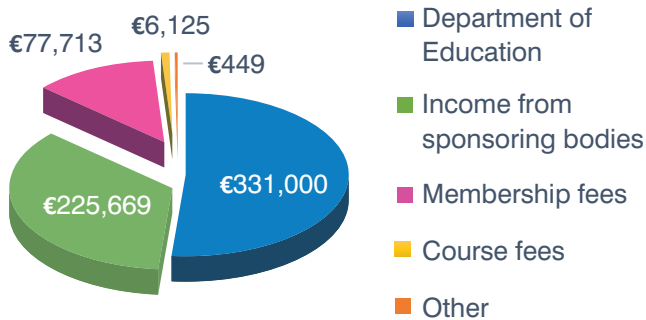

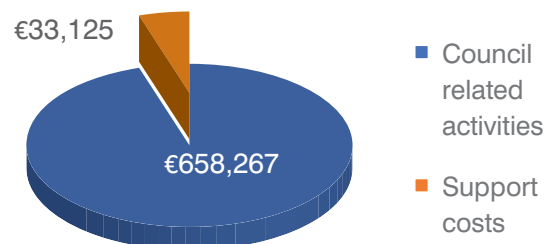

Chairperson's Report



It is my pleasure on behalf of the Board of Directors to present the 2020 review of the National Parents Council Primary (NPC).

In preparing the Annual Report and Financial Statements the Board seeks to clearly demonstrate the activities of the organisation, its impacts and benefits and how it organises and funds its operations in line with principles of good corporate governance and transparency.

It is fundamental to our organisation that the highest standards of Corporate Governance are maintained. Our commitment to delivering a quality and efficient service, now and into the future, has continued, in spite of the COVID-19 pandemic.

In this regard, NPC is independently governed by a Board of Directors, comprised of 10 voluntary members who receive no remuneration for their services. The Board is charged with the responsibility of administering NPC on a not-for-profit basis.

The Board has two committees, Finance/Risk/Audit and Governance. During 2020, the Board met six times and the two committees also met on several occasions, with all meetings taking place virtually in line with public health guidelines. Minutes were prepared for all meetings.

2020 was like no other year for our society, educational sector and our organisation. I would like to recognise and acknowledge the challenges faced by many families, many of whom have been in contact with NPC via the various channels. Undoubtedly the services and advocacy provided by our organisation are now needed more than ever and provide a vital link and connection to parents. The board are cognisant of the role to oversee and steer the organisation. The organisation's board committees continued to work with a special focus on the areas of risk assessment, mitigation and finance scenario planning while also ensuring compliance with the charity regulators Code of Governance.

I would like to take this opportunity to acknowledge and thank all the Board members for their invaluable contributions to NPC in 2020. Finally, I would like to extend my gratitude to Áine Lynch, our CEO and the staff of NPC whose commitment and dedication to NPC's Vision on our behalf ensures that NPC continues to improve the experience of children and parents in primary and early years education.

Chief Executive Officer's Report



With the onset of the COVID-19 pandemic in March 2020, staff of NPC showed their agility and commitment to work in an unprecedented way that would allow us to meet the challenges of the pandemic. As a result of this, NPC's commitment to its 'core objectives' never wavered, and in fact, our services continued to grow and develop. However, the pandemic did necessitate some fundamental alterations to our service offerings, and indeed, an immediate and total reimagining of our service delivery.

While COVID-19 may have dominated the year, it did not negatively impact our strategic goals or long-term vision for NPC. Significant progress continued to be made on the implementation of each of the objectives of our Strategy, "Parents as Partners; Children, Schools and Communities". This strategic plan spans 2018 to 2022 and recognises the unique role we play in representing parents' voices in education and supporting them to support their children through these important years of education. Representing parents' voices was never more vital during 2020 amid school closures, remote learning, and continued restrictions. In 2020, we heard from over forty-seven thousand (47,504) parents through our surveys on a wide variety of issues. This was an increase of 350% on 2019. The survey that gained the most responses from parents was on the issue of "Your Child Returning to School" which received over twenty-eight thousand (28,744) responses.

The service delivery in 2020 was again very busy, albeit with a very different approach to providing supports to parents. In March 2020, with the first school closure it became very clear, very quickly, that parents needed support in providing fun learning activities for their children. In response to this NPC provided a "Daily Edition" of varied unique resources throughout the period of school closures. NPC worked with artists, chefs, musicians and exercise and wellbeing experts to develop video content for parents to use with their children.

During 2020, NPC continued to respond to parents' concerns through the helpline. At times, due to restrictions, the helpline was only able to operate through email but when possible, we reopened the telephone lines as quickly as was possible with the Helpline answering 1,820 calls and emails during the year. Our training supports which are normally delivered in schools was severely impacted by restrictions and school closures. However, we quickly adapted our training provision to deliver supports via video and zoom with 4,217 parents attending in person or via zoom live training events and 44,000 parents engaging with training videos which were developed to support transitions from early years to primary and from primary to post-primary settings. The mental health and well-being session was again the most sought-after training in 2020 with 1,732 parents attending. The level of engagement by parents in our services continues to indicate that NPC supports are valued and relevant to parents of primary school and early years children.

COVID-19 made the NPC Annual Education Conference impossible as an in-person event, however, NPC recognised that it was essential that parents did not receive less support at this time. Instead of the normal in-person event, NPC provided a series of webinars every Wednesday evening during the month of October on different areas of well-being and mental health supports. These seminars were provided in partnership with Dr. Colman Noctor who presented on four different topics, which was followed by a question-and-answer session with participants. The seminars proved incredibly popular with over 7,500 parents attending.

In closing, I would like to acknowledge the continued trust of parents in our organisation and the dedication of the Board and staff members of NPC who went above and beyond over the course of a difficult year to ensure that we could continue to provide high-quality supports, services and advocacy for parents.

Early Years

The NPC Early Years' service was established and developed in order to support parents to support their children both at home and in pre-school and to represent their voice in the Early Years' sector.

Training

NPC delivered face-to-face training in February and March 2020 on the topic of supporting your child's transition from pre-school to primary school.

To enable NPC to continue to support parents through COVID-19 restrictions NPC developed an online training session for parents.

NPC designed and delivered our first early years webinar in partnership with the National Council for Special Education entitled "Let's Talk About Your Child's Special Educational Needs When Starting Primary School". This event was designed to support parents to support their child's transition from pre-school to primary school.

NPC also worked in partnership with St. Patrick's Mental Health Services to develop a programme to support parents to support their young children's positive mental health in the early years. NPC successfully ran a pilot programme in December 2020 and will run further workshops in 2021.

Helpline

In 2020, NPC continued to support parents with an early years' helpline service, which is available via telephone, email and webchat.

Helpline

2020 understandably saw a large number of contacts to the Helpline, via phone calls and email in relation to the impact of school closures due to COVID-19. We heard from many parents about the social, emotional and psychological impact of primary schools being closed.

The Helpline operated from mid-March to mid-June 2020 by email only in view of the strict public health guidelines in place at that time. From June 2020 to December 2020 the Helpline operated by both phone and email.

Of note in 2020 we saw a growing number of queries from Parent Associations regarding the rules governing the effective and efficient functioning of Parent Associations.

The Helpline saw an increase in the number of Early Years' calls and emails in 2020. This reflects the growing awareness of the Early Years' Helpline service of our service.

Training and Development

The NPC Training and Development Programme continued to deliver training and support to parents throughout 2020.

AIMS AND OBJECTIVES

The Training and Development Programme supports parents to work in positive partnership with the school, and it seeks to empower parents in their role as the primary educators of their children and encourages a positive role for parents as part of the whole school community.

TRAINING PROGRAMMES DELIVERED IN 2020

COVID-19 significantly impacted NPC's ability to provide training supports for parents as training sessions typically take place in schools. With the schools being closed or affected by social distancing restrictions for the most part of 2020, NPC had to completely redesign its training service to adapt. All NPC training programmes were redesigned to suit online delivery and all NPC trainers were upskilled accordingly.

NPC provided 264 training sessions to a total of 4,217 parents in schools across Ireland, six different training programmes for parents were offered countrywide.

Anti-Bullying Training

This programme enabled parents to support their children regarding issues of bullying and also informed them about the Anti-Bullying procedures in primary schools. This training was funded by the Department of Education under the Anti-Bullying Action Plan.

Parents' Association/Parental Involvement Training

This programme gave information and guidance to new and established Parents' Associations. The aim of the programme was to inform Parents' Associations on their role as part of the whole school community and to give parents an understanding of the importance of parental involvement in the home and school. It aimed to support and facilitate parents in developing a positive partnership in the school as a community. School closures and restrictions prevented this training happening in the usual way, therefore an online PA clinic was held once a week, this enabled parents to find solutions and share ideas with other parents from all across the country. This training was funded by the Department of Education.

Internet Safety Training

This programme focused on strategies for both improving communication between parents and children and negotiating boundaries to children's internet use. Parents were given the skills to engage with their children's online lives. Through the training, parents were also informed about how young people use the internet, what attracts them to the internet, and gained an insight into children's main worries and concerns when online. This training was co-financed by the European Union, Connecting Europe Facility and Virgin Media.

Parenting – Supporting your Child to Build Healthy Friendships and Relationships

Parents attended information sessions which informed them about the Social Personal Health Education (SPHE) curriculum and what they can do to support their children in building healthy friendships and relationships. Parents also attended a three session parenting workshop which delved more deeply into topics such as communication and social, emotional and physical development of children. This programme is funded by the HSE, Sexual Health Crisis Pregnancy Programme.

Supporting Parents to Support their Children's Mental Health and Well-being

This programme supported parents to encourage and promote positive mental health and well-being with their children. It also explored how the building of resilience in children helps them to manage and cope with the day-to-day stresses of life as they occur. This training was funded by St. Patrick's Mental Health Services.

Transition from Primary to Post-Primary Training

This programme was provided for parents whose children were in 4th, 5th or 6th class. It supported parents to reflect on their own feelings about their child transitioning from primary to post-primary school. It also gave them useful information on subject choices and an insight into the post-primary education system. This training was funded by the Department of Education.

Partnership Schools Ireland

The Partnership Schools Ireland (PSI) programme aims to ensure better outcomes for children by promoting partnerships between schools, families, and the wider community. It is a joint initiative by the National Parents Council Primary and the Irish Primary Principals Network and is part-funded by the Department of Education.

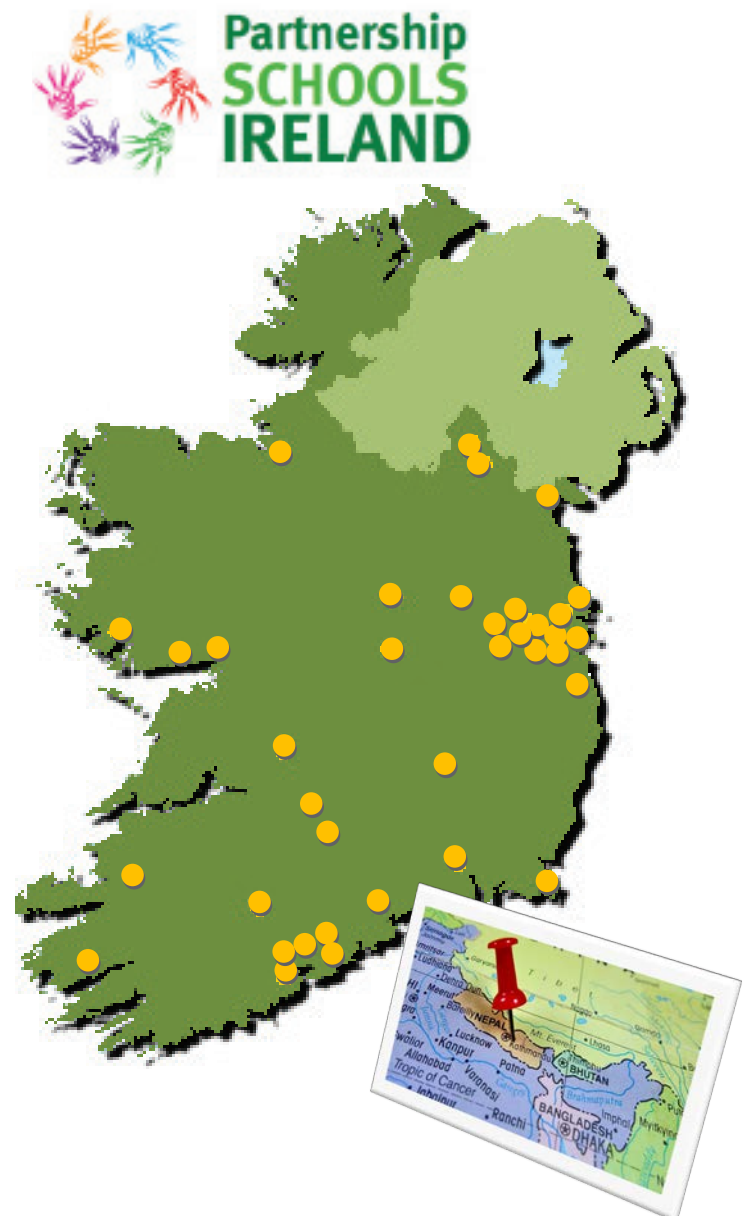
The PSI programme is based on Dr Joyce Epstein's model of school, family and community partnerships. For over 40 years, this research has shown that when strong families, excellent schools and healthy communities overlap and work together they provide the best possible opportunities for children to thrive. Children who have the support of their families, schools and communities are more likely to feel more positive about education, have more positive social, emotional and behavioural development, have better school attendance, perform better academically and adjust to school life more easily.

With school closures and public health measures, the COVID-19 pandemic impacted our ability to run training sessions for schools. Therefore, in 2020 three schools completed PSI training, bringing the total number of schools trained to forty one. Two of these schools were trained in Ireland, and an additional school in Nepal. Members of Shwet Barahi School, Kathmandu, Nepal completed their PSI training with NPC CEO Áine Lynch who was in Nepal supporting the Irish Charity, Indreni, to promote partnership with parents in their schools.

Over the past number of years, work has been ongoing to develop an online Team Training Workshop. This course is designed to support schools who have already received their in-person PSI training. The Online Team Training Workshop can be used as a refresher for a whole group who have trained before, or new members of the Action Team Partnership (ATP) who were not present for the initial training course. The training was developed and made available in early 2020 to any school who had already received PSI training.

Partnership Schools Ireland earned a 2020 Partnership Organisation Award from the National Network of Partnership Schools (NNPS) at Johns Hopkins University for this Online Team Training Workshop. This is Partnership Schools Ireland's second NNPS Partnership Award – the training was praised for its clarity, artistic quality and comprehensiveness. The NNPS were impressed with evidence that the programme is scaling up the number of schools, and that the online workshop will enable the small number of NPC staff to conduct remote training with a large number of interested schools.

Finally, the first *Promising Partnership Practices Ireland* booklet was printed and distributed in early 2020. It documents the partnership work of schools across Ireland and provides the wider community with an opportunity to hear about the positive work that is happening in Partnership Schools. Going forward, an annual *Promising Partnership Practices Ireland* booklet will share the goals, actions, and experiences of Partnership Schools.



Communicating with Parents & Children

In line with the NPC strategic objective to develop two-way communications and ensure the delivery of quality information, NPC, in 2020, despite COVID-19 restrictions, continued to communicate with parents and children via the website, social media and surveys.

Due to COVID-19 restrictions, and the resulting school closures, 2020 proved to be a very different year for NPC and a difficult year for parents and children. From March 2020 onwards we were unable to hold face-to-face training sessions, conferences, regional assemblies etc. and had to be more creative in our communication with parents.

Website

The NPC website www.npc.ie aims to provide parents with information regarding NPC and information on primary and early years education.

In 2020, the NPC website truly became the main communication hub for the organisation. In addition to showing up-to-date newsfeeds on issues of interest to parents of children, to support parents and assist them with their children's home learning during school closures, the website became a repository of resources for parents including daily tips, expert videos and free webinars. There were also videos and fun daily activities for children provided. During 2020 the website had 110,110 users, an increase of 105% from 2019.

Webinars

Webinars for parents commenced in October 2020 and proved to be hugely popular, especially the 'Let's talk' series of webinars by Dr. Colman Noctor:

- Let's talk about connecting with your child
- Let's talk about helping anxious children
- Let's talk about your child's online life
- Let's talk about building your child's social savvy

Over 7,500 parents attended the webinar series.

NPC also hosted a webinar entitled 'Let's talk about supporting your child's additional needs when starting Primary School' by Laura Berry, a Special Educational Needs Organiser (SENO) working with schools to allocate additional supports to children who need them and a webinar entitled 'Gender Equality Matters' with Dr. Bernie Collins, which focused on tackling gender-stereotyping and gender-based bullying.

In 2020, member Parents' Associations found themselves in very different situations, trying to communicate with parents whilst not being able to meet. To assist Parent's Associations, NPC developed online guidelines for Parents' Associations with regard to COVID-19, including information on holding AGMs.



Social Media

In addition to the NPC Facebook account launched in 2019, NPC launched Twitter and Instagram accounts in March 2020 to make it easier to share information with parents during COVID-19 restrictions and to allow parents to easily share information with one another.

Surveys

NPC gives parents and children the opportunity to share their views with the organisation regarding primary and early years education issues by way of surveys promoted on the website, social media and circulated to members and NPC contacts. The results of the surveys formed the basis of submissions to the Department of Education, the Department of Children, Equality, Disability, Integration and Youth and other key stakeholder organisations.

In February 2020, NPC ran a snap 24-hour survey to find out about schools and their partnership with parents. The survey aimed to ascertain if schools had Parents' Associations and their policies regarding parental involvement and parental engagement. There were 1,471 responses to this survey.

NPC, in conjunction with researchers in the School of Education at NUI Galway, ran a survey to explore parents'/guardian's and children's experiences of 'Schooling at home' during COVID-19 from the 22nd of June to the 10th of August 2020. There were 3,005 responses to this survey.

Further to an invitation to meet with the Special Committee on COVID-19 Response looking at the Impact of COVID-19: Education – return to school and school transport, NPC ran a snap 24-hour survey from the 25th to the 26th of June 2020 in order to inform discussions and to ensure parents' views were included, this survey was entitled 'Your child returning to school'. There were 28,744 responses to this survey.

NPC was invited to make a submission to the Oireachtas Special Committee on COVID-19 on the 'Preparations for the reopening of schools and how reopening is operating in practice'. To inform the submission NPC surveyed parents of primary school children to find out about parents' and children's experience of the first days of the schools reopening after summer 2020. There were 3,175 responses to this survey.

Further to an invitation to make a written submission to the Joint Oireachtas Committee on Education on the topic of 'Ensuring that Schools are open in a manner which is both safe and sustainable' to inform this submission, NPC ran a snap survey from the 19th to the 20th of October 2020 there were 11,109 responses to this survey.

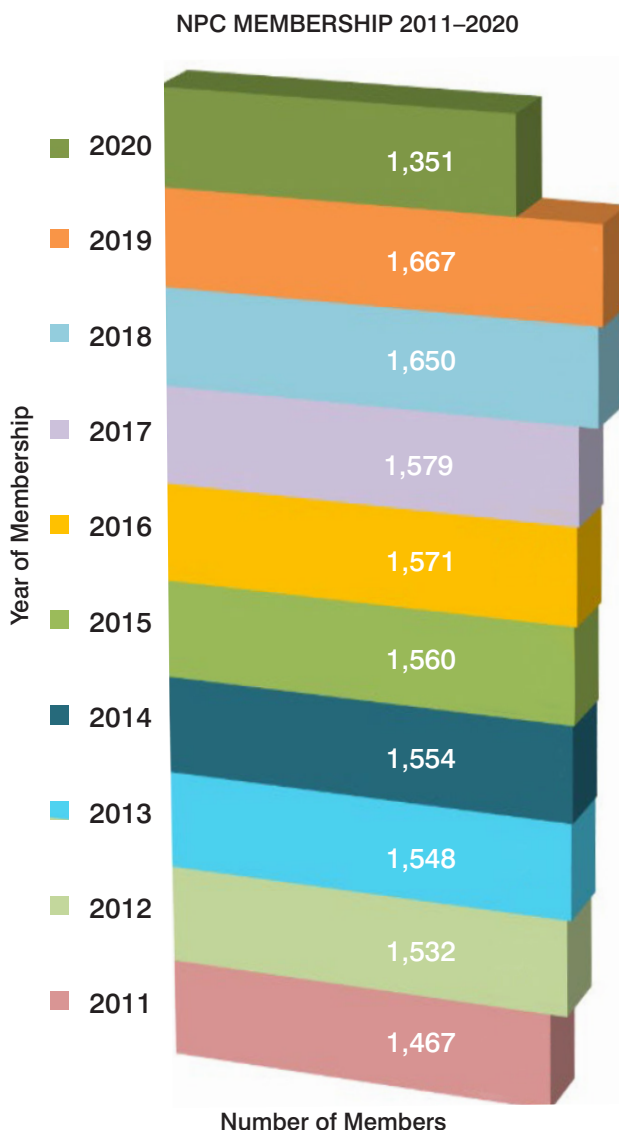
Fred O'Connell NPC Innovation Award 2020

The NPC Innovation Award recognising innovative partnership between parents and schools was deferred to 2021, due to COVID-19, to enable Parents' Associations to submit projects.

Membership

NPC during COVID-19

2020 proved to be a very different year for everyone, parents suddenly found themselves in situations where they had to home school their children, while trying, in many cases, to juggle their own work at the same time. Children had to try to get used to learning at home with their parents acting as their teachers, not always an easy situation for either.

NPC had to reimagine our way of working to be able to support parents and children during COVID-19. To do this we created 'Daily Editions' online and social media supports. As face to face conferences couldn't be held we provided webinars for parents and all our training was adapted to be available online and new training sessions were developed.

Daily Editions

NPC tried to assist parents by providing 'Daily Editions' which included a variety of resources: hints and tips for learning at home, fun activities to do with children, expert videos by chefs, fitness instructors, mental health and wellbeing advocates, musicians, storytellers etc.

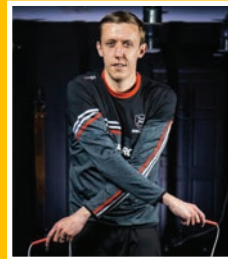

Webinars



Starting in October 2020, NPC provided a series of webinars for parents every Wednesday evening. The first four webinars were provided in partnership with **DR. COLMAN NOCTOR** who presented on four different topics:

- Let's talk about connecting with your child
- Let's talk about helping anxious children
- Let's talk about your child's online life
- Let's talk about building your child's social savvy



The fifth in our series of webinars was aimed at parents of children with special educational needs and was presented by **LAURA BERRY**, a Special Educational Needs Organiser (SENO). This webinar was entitled: 'Let's talk about supporting your child's additional needs when starting Primary School'.



The final webinar in the series was presented by **DR. BERNIE COLLINS**, researcher and educator on Gender Equality Matters (GEM) and was entitled 'Gender Equality Matters' and focused on tackling gender-stereotyping and gender-based bullying.

Online training

New online NPC training sessions were provided for parents of children transitioning from pre-school to primary school and from primary school to post primary school. It was a particularly tough time for children in 6th class who missed out on so much of their last year in their primary schools. Our training aimed to assist parents to support their children as they prepared for this major event in their lives.

All of NPC's existing face-to-face training sessions were adapted so that they could be provided virtually for parents and a new Early Years' training session was developed in conjunction with St. Patrick's Mental Health Services to support parents to support their young children's positive mental health.

Structure, Governance and Management

Governing document

The organisation is a charitable company limited by guarantee, and not having a share capital incorporated in the Republic of Ireland under the Companies Acts 2014 on 10 December 1999. The Council does not have a share capital and consequently the liability of members is limited, subject to an undertaking by each member to contribute to the net assets or liabilities of the company on winding up such amounts as may be required not exceeding €1.27.

The Council was established under a Memorandum of Association which established the objects and powers of the entity and is governed under its Articles of Association and managed by a Board of Directors.

The Council has been granted charitable status under Section 207 and 208 of the Taxes Consolidation Act 1997.

The Council comply with the Governance Code for community, voluntary and charitable organisations in Ireland. The Council confirm that a review of the organisation's compliance with the principles in the Code was conducted on 11 September 2020. This review was based on an assessment of our organisational practice against the recommended actions for each principle. The review sets out actions and completion dates for any issues that the assessment identifies need to be addressed. All actions from the previous review have now been completed. The next review is due to take place during 2023.

Recruitment and appointment of the Board

In accordance with the Articles of Association one third of the elected directors in office must retire each year. If the number of directors is not divisible by three, then the lowest whole number nearest one-third shall retire.

The directors appointed in general meeting may co-opt a further two directors for a term of up to three years on such terms and subject to such conditions as the Board may determine and such co-opted directors shall be eligible for re-appointment at the expiry of their term of office.

The Board nomination process has followed a process in accordance with the NPC revised Constitution which provided for the members of the NPC to nominate people for election to the Board. Following the nomination stage, an electronic voting process was conducted which facilitated all NPC members to elect the Board members to fill the vacancies that arose.

The Board is committed to achieving high standards of governance. Board members do not receive any remuneration in respect of their services to the Council. Expenses are reimbursed where claimed. There have been no contracts or arrangements entered into during the financial year in which a Board member was materially interested.

All new Board members receive induction training and induction papers on commencing their appointment to the Board.

Organisational Structure

The Board of National Parents Council – Primary is permitted to have a maximum number of directors of ten: up to eight of whom may be elected by the Full Members (affiliated Parents' Associations) and up to two of whom may be co-opted by the Board of Directors.

The Board are responsible for the strategic direction and policy of the National Parents Council – Primary. This is in accordance with the Memorandum and Articles of Association and the National Parents Council – Primary Governing Handbook. At present the Board has ten members, eight appointed in general meeting and two co-opted by the appointed directors.

Audit Committee

As part of the Board's plans to fulfil its objectives in this area it has constituted an audit committee to ensure an effective review and monitoring of financial risks, reliable management and financial reporting, compliance with laws and regulations and the maintenance of an effective and efficient audit.

Chief Executive

The Chief Executive of the Council reports to the Board of directors. The Board provides leadership and strategic management, developing and furthering the aims and objectives of the organisation and delegates certain duties and responsibilities to the CEO. This includes implementation of the strategic plan, leading and managing the Council's staff members, programmes, projects, finances and all other administrative aspects so that the Council's ongoing mission,

vision and objectives are fulfilled within the context of the Council's values, as approved by the Board of Directors and membership.

Key Risks

During 2020 and continuing into 2021, an outbreak of COVID-19 spread throughout the world. In Ireland, the impact of the pandemic has been characterised by the temporary closure of many businesses and organisations in "non-essential" areas to ensure people's movements are restricted in order to slow down the spread of the virus. The National Parents Council Primary has been able to continue operating during the pandemic period but the offices have had periods of closure or partial closure when some or all staff have been working remotely from home. This has changed the way that NPC have offered supports to parents but not prevented service provision. However remote working has had an impact on a number of activities that have not been able to continue during the COVID period:

1. The most significant impact has been on face-to-face training. During the remote working period and school closure no face-to-face training has taken place, however towards the latter part of 2020 from September onwards remote training was developed and implemented successfully and has temporarily replaced the face-to-face training during times of social restrictions.
2. Partnership schools – during school closure no new schools have been trained in the partnership schools programme.

Objectives and Activities

The principal activities of the Council are to act as a nationwide organisation representing parents of children attending early and primary education.

National Parents Council – Primary was established to contribute to the advancement of the early education and primary education of all children, in order to improve and enrich the education of each child and to support the involvement of parents in all stages of education.

Vision

The Council want to see an Ireland where every child has the opportunity to reach their full potential.

Mission

The Council exists to ensure that all parents are supported and empowered to become effective partners in their children's education. The Council will work to increase the capacity and capability of the primary education sector, to achieve true partnership and deliver better outcomes for all children.

Key Activities


The key activities in achieving the vision and mission of the Council are:


1. Representing the parents' voice in primary education
2. Advocacy
3. Building participation
4. Service delivery

Achievements and Performance

The Council publishes an Annual Review outlining the achievements of the organisation under its Strategic Plan's Aims and Objectives.

Financial Review

The Council reported an operating deficit of €50,636 in the year (2019: deficit €4,104). This was due to the impact that the COVID-19 restrictions had on the operation of some of our services, most significantly our parent training programmes. In addition as schools were closed for a substantial period of the 2020- 2021 school year, NPC's members (Parents Associations), were less active which impacted on NPC membership renewals during the 2020 period.

The principal sources of funding received by the Council are from funding grants from the Department of Education and the Health Service Executive. The Council also receives funds from its membership subscriptions and publication sales.

The Board has examined the Council requirements for reserves in light of the main risks to the organisation. It has established a policy whereby the unrestricted funds not committed or invested in tangible fixed assets held by the company should amount to between three and six months of average expenditure.

Accounting Records

The directors believe that they have complied with the requirement of Sections 281 to 285 of the Companies Act 2014 with regard to keeping adequate accounting records by employing accounting personnel with appropriate expertise and by providing adequate resources to the financial function. The accounting records of the company are maintained at the company's offices at 12 Marlborough Court, Marlborough Street, Dublin 1.

Going concern

As set out in Note 1 of the financial statements, the Council has assessed the impact of the COVID-19 pandemic on its operations at the date of approval of the financial statements. This assessment encompassed a detailed recent review of the future outlook of the company which demonstrates that the Company should have adequate resources to continue operating for at least the 12-month period from the date of approval of the financial statements.

Accordingly, the directors consider it appropriate that the Council prepares its financial statements on a going concern basis.

Plans for Future Periods

National Parents Council - Primary's Strategic Plan; "Parents as Partners" will shape the plans and direction for the organisation until 2022.

Relevant Audit Information

The directors believe that they have taken all steps necessary to make themselves aware of any relevant audit information and have established that the company's statutory auditor is aware of that information. Insofar as they are aware, there is no relevant audit information of which the company's statutory auditor is unaware.

Auditor

In accordance with Section 383(2) of the Companies Act 2014, KPMG, Chartered Accountants, will continue in office.


- select suitable accounting policies and then apply them consistently;

Opinion
